Additionally, the law states that any individual who reasonably believed they are being treated by a licensed clinical social worker (LCSW) may claim confidentiality of their records.

LCSW's and social workers under the supervision of a LCSW also may invoke the right of confidentiality of client records. The organization also makes a law book on confidentiality, which includes information on dealing with subpoenas, available to members. When social workers do have to reveal confidential client information, it is important that they do so openly and in a way that maintains the client's dignity. Confidentiality means that information shared within a relationship will not be shared outside that relationship. The social worker's obligation to keep client information confidential is supported through state and federal law,
